PROJECT SCOPE AND SPECIFICATIONS

The Project Scope and Specification are:

Friends Aware, Inc. has been awarded funding through the Cumberland Development Block Grant (CDBG). To provide upgrades to an existing 30,000 gallon, 15' diameter X 20' tall, water tank which will include final tank inspection, replace roof vent with new vacuum pressure frost proof and screen vent, interior robotic sediment removal, installation of Davit Arm Shell Manway, electrical grounding of the tank, installation 2, 30" secondary Shell manway and 180 degrees primary manway complete w/Davit Arm, installation of anti-skid exterior rung covers, a cable type ladder safety device exterior access ladder, a lockable ladder guard, posting of all required signage, installation of swing gate junction of shell roof access ladder and tank roof, post all confined space signage, installation of a compliant interior access ladder with standoffs every 10 feet on center at secondary roof hatch, installation of cable ladder safety device for interior access ladder, drain and refill water tank as required.
